

Pascom 10 – the ball is rolling now

Since my last communication, much has happened. PASCUM (P-10) was launched on 1st May and some 71 centres have registered already, with approximately 100 podiatrists and 500 patient entries. Our trainers are doing a great job and this will be on going for the foreseeable future.

The Society is investing heavily on your behalf with this project and it will make a significant difference to both private and NHS evidence in time.

I have written to the Professional Practice committee to ask for its endorsement for the text free boxes for clinical notes to be accepted within the passport for good practice. Having used this on my own patients for clinical note taking, I realise how valuable this element will be for all clinicians and particularly for private practitioners who want paperless systems.

Data transfer

A new benefit is the fact that you can transfer patient data to different sites. So if Mr X (podiatrist) treats Mrs White and Mrs White has been to Miss Y (podiatrist) and Mr X would like to know what was done, Miss Y can give permission to transfer notes across by a process of signing acceptance. Mrs White can take her unique P-10 code anywhere and give this to the next podiatrist who can then retrieve the previous episode history. We hope that in time all members using the system will appreciate the value of data transfer – private to NHS and vice versa.

R&D committee

PASCUM has now joined up with the Research & Development group so is part of this committee although functions as a clear sub entity to service P-10. Alan Borthwick, R&D chairman, and the committee welcome the joint participation and we hope to drive through a strong evidence-based flavour to the product.

MEETINGS FOR YOUR DIARY

England: Our last English session is on 13 September in Birmingham. Remember you need two days to receive your certification for training so you will also

need to participate in one of two days held in Edinburgh on 20/21st November.

We have places for 'administrators' who have been unable to obtain training for their own practices or NHS units. These are only open only to podiatrists.

Consultant podiatric surgeons should not apply. Most podiatrists will not want to be trainers and remain users. Please enrol with a local trainer. Podiatrists wishing to become administrators may enrol for Birmingham. Please note this is a half day course only costing £30.00 payable to the Society 'PASCOM'. Payment can be brought on the day. These will be half day only AM/PM.

Administrators perform the function as 'users' but are responsible for internal training for their Unit only and cannot train outside the centre. This group can handle data, admit new members to the system and act as reporters for their own centre data. 'Users' train for three hours while 'administrators' require more information. They cannot charge for services and typically would run their own private practice or share responsibility in an NHS centre with another colleague. More details are available on request.

Administrators work with trainers once a unit is set up and are expected to work with clinical governance and Trusts. We have a full suite of computers and webmaster trainers in attendance with live experience of the new PASCOM-10 system.

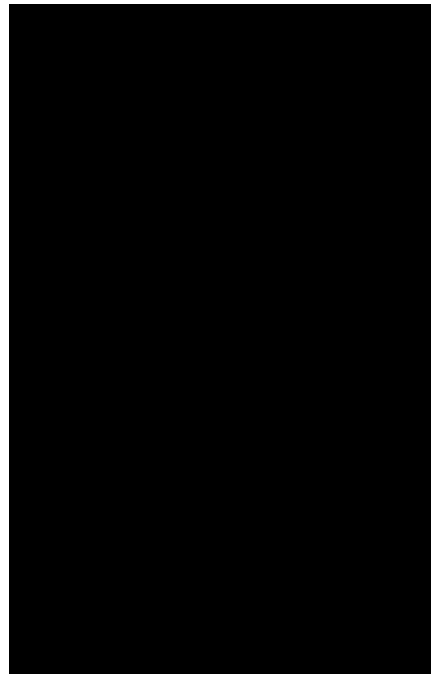
